### ACC:

- Re: fences

  - There's a process for new neighbors to go through with the ACC
- No record keeping; therefore, we have no way to know what was approved, variances, etc
  - Proposal: starting now, we should create a log of fences, and then be thorough in communications and consistent with approvals
- Add to newsletter again about covenants for any construction, in particular fences
- It has happened that the HOA has persuaded and succeeded in making a homeowner take down a non-compliant fence.
- Revisited last month's discussion of the falling down fence on Oxwood Circle. Would like to encourage homeowner to remove the fence. Board to offer to help.
- Reviewed fence stipulations; the covenants state a 36" fence is allowed. (There seems to be a discrepancy in whether approval is still needed.)
- January board meeting minutes stated that ACC would no longer to approve fences.
- Discussion of YouTube video (public video)
  - $\circ$   $\;$  Currently called "Fence Violations" but not everything in the video are violations
    - Pool fences are required
    - Decorative fences are not violations
  - Motion to remove from YouTube but retain for reference if needed?

    - All voted in favor
