A note from the President

Happy fall to all. I am excited to share that we have grown so much over this past year. We have been fortunate to welcome 18 new home owners to Walnut Grove in 2019! These are new neighbors that want to connect and be a part of all of the great things many have enjoyed in Walnut Grove over the years. I am so appreciative of our Board and all of our Block Captains that connect with everyone. As a home owner since 1992, Block Captain and on the Board for many years, that means that we are a great place for many to call "HOME." That is important as everyone wants to be a part of something bigger. My 3 daughters grew up here and still feel happy to come back home. We have chosen to stay here because of all the great tangible and intangible things in our neighborhood.

Walnut Grove is unique and our greenways exemplify that in the city of Madison! We have lit paths that connect the circles and lovely groves of trees. These greenways require regular care on a weekly, monthly and annual basis. They also require larger projects (such as re-paving or tree removal) on a less frequent basis. This is accomplished by a group of dedicated volunteers and our annual homeowners fees. We currently have some of the lowest homeowners fees in the area. We are paying \$75 annually per household, which is the cap of fees that was set in 2005. In order to guarantee that we are able to continue to maintain our greenways in the future, the board will request that the membership approve an increase in the annual dues. We have not yet determined what the cap should be and will welcome input from the membership. The board and I look forward to discussing this more with you all in the future and at our annual meeting in January 2020. We want every neighbor to enjoy Walnut Grove in the years to come!
