March 16, 2021 President Report

- February and early March have been focused on follow ups regarding dues notices and initial communication regarding Alder Candidate forums.
- Paul Skidmore notified me via phone of the weapons violation on Gammon Road Tuesday, March 9th. The information was already posted on the MPD incident reports prior to his contacting me. - By-laws, Covenants and ACC Rules & Procedures projects from 2020 are all wrapped up, with final copies of all Owner Signature Sheets sent to Stafford Law so they have copies on file.
- Getting quotes for possible fence removal on Oxwood Circle no longer an option as buyers have already begun looking at the home.
- Pam Conrad reached out regarding a "Master Recycler" program and offered to attend
 (\$15 fee) and provide educational write ups for future emails/newsletters.

- Garage Sale Inquiry: Prior to COVID, Derek Pavelec helped organize the WGHA garage sale weekend, which was usually the 3rd weekend May to coincide with the Wexford garage sales. We didn't have a sale in 2020. Derek is willing to help organize if we want to have neighborhood sale in 2021 and has offered to poll the neighborhood on Nextdoor to get an idea of how many people would be interested and ask if they would prefer Spring or move it to Fall in hopes that more people will have a vaccine and restrictions will be lessened. Before taking any next steps, Derek wanted to run this by the Board for comments on whether the WGHA is willing to sponsor a neighborhood sale or if we will be skipping another year.

Walnut Grove Homes Association --March 16, 2021 Greenways Report

First Committee Meeting: Davie would like to be at the first committee meeting with me and we both thought it would be nicer to wait to meet in person at the park. We are hoping in the next week or two to be able to do this. I, in the meantime, have been emailing individually to introduce myself.

Mowing: After talking with Davie about Green Team, we have decided to request bids from other mowing services. Overall, David was dissatisfied with their work and their inability to follow directions. I have requested bids from Barnes, Maple Leaf, Mendez Lawn Care, and Capital Turf Lawn Care. Davie and I will be working together to explain the job to each service.

Keyman Prepayment: Prepayment was due in January for the 2021 season. I am waiting to hear back as to when the first application will be completed. Pam Conrad wants to request that they not do the greenway behind her house so she can add soil and grass seed I will let her know as soon as I have spoken with the staff at Keyman.

2020 Removal/Replanting: Eco Tree Company still has two ash trees on Oxwood Circle to remove and all of the stumps from the earlier removals need to be taken care of. Davie is following up with this.

Davie and I have been discussing future tree removals and the replanting of those trees, but I do not have a formal plan outlined. Other than the Ash tree treatmentsThe treatments for the ash trees is obviously established and the plan is to continue with Olson. Once we have the mowing settled for the season, I shall turn my attention to this. Davie and I have great plans for walking the greenways.

Path Maintenance and Replacement: For the longer term issue of path maintenance, repair and replacement David and I have discussed only that he was not impressed with the company that did the work in 2019 (Bartelt) and that we ought to look elsewhere. I've been in contact with Jim Rather who is the Wexford Village Neighborhood Association's contact person to discuss their greenway paths. Davie and I have both walked their paths and wondered if they had them plowed so I reached out to ask. It turns out they don't have them professionally plowed because of the liability issues. I thought to reach out to him again to ask what service they use for general maintenance and repair.
