Minutes of the Walnut Grove Homes Association, Inc. Annual Meeting January 25, 2023 7:00 pm (via Zoom)

Due to the continuing potential for Covid exposure, and to simplify and promote greater participation, the annual meeting of Walnut Grove Homes Association, Inc., was conducted by Zoom for the third year in a row. Doug Hyant, WGHA Vice-President, hosted and moderated the meeting.

The meeting was called to order at 7:05 pm by President Liz Fenster, who welcomed all the participants. Mr. Hyant then explained the procedures to be followed in the meeting, including the on-line poll voting method for motions introduced in the meeting.

Attendees:

Board Attendees: Liz Fenster, Doug Hyant, Nick Brown, Molly Hyant, Charlie Morgan, Danielle Bashirullah, Eileen Goode, Hayden McCann and Kim Grimmer.

Homeowner Attendees: There were 42 WGHA homeowners/participants present for the Zoom meeting, with one attending by phone.

21 proxies were presented and recognized for voting purposes.

- o 20 proxies were given to the WGHA Board (One proxy assignor came onto the call)
- 1 proxy was given to Liz Fenster

A quorum was declared under the Association's 2020 By-laws, with 62 homeowners present in person or by proxy.

The Board members introduced themselves.

Approval of 2022 Annual Meeting Minutes

Ms. Fenster invited a motion to approve last year's Annual Meeting minutes. Charlie Morgan so moved, seconded by Nick Brown. The motion passed unanimously, including proxies. (*See*, Appendix A, below, for totals of votes in person and by proxy on all motions made in this meeting.)

Agenda for Meeting:

Ms. Fenster screen shared the PowerPoint presentation and agenda. (*See*, Appendix B, below.) Ms. Fenster discussed:

WGHA participation in the new Madison Metro Transit Network Redesign and Ms. Fenster
reviewed the changes coming for bus service to the neighborhood in June 2023, including easy
access to the Rapid Transit component. She showed the new transit map and discussed the
Rapid Transit going into effect in 2024. No routes are coming down Westfield Road through the
neighborhood. Ms. Fenster thanked members who played significant roles in liaising with
Madison Metro: Meghan Johnson and Ethan Nelson.

- The single track bike trail at Walnut Grove Park may have stalled out. The project has been
 placed on indefinite hold by the Madison Parks Department. Ms. Fenster discussed our own
 survey on the bike trail and the petitions on it. The Tamarack Community took an official
 position opposed to it. The potential of this project can be followed at the City's website here.
- Pheasant Branch Watershed and Sauk Creek Greenway. Ms. Fenster reviewed the status. This
 project is to help address the severe flooding that occurred in August 2018, when much of the
 Pheasant Branch Conservancy in Middleton was washed out. This project calls for the removal
 of trees, primarily invasive species, and will affect the wooded area west of Walnut Grove Park.
 Neighbors can sign up for updates on the City's website on this project here. Final development
 plans for this project will await further community engagement meetings.
- North Westfield Road Traffic Calming Project. Ms. Fenster reviewed this effort that began some two years ago by a handful of neighbors banding together to express to City Traffic their concerns about the speed of traffic along Westfield Road in the vicinity of the Walnut Grove Park, lack of visibility during events in the park, including soccer games, and crosswalks being ignored by motorists. Construction should begin between April and July of 2023 (and take approximately three weeks) to install three speed humps in the vicinity of the park, newly painted crosswalk in continental marking style, and two traffic islands at Westfield on both sides of the Farmington intersection. In addition, the speed limit on Westfield will be reduced to 25 mph from 30. Details on these traffic changes are available on-line here, see Exhibit B, last page of the WGHA board minutes of April 11, 2022.

• Principal 2022 Achievements:

- \$15,000 added to the Legacy Fund for the Greenways.
- o Neighborhood Signage repair (Ron Wynne) and repainting (Natasha and Kenton Soglin).
- Hayden McCann led a project to obtain and replace native perennial plants using a grant we obtained.
- We continued to work on bids to repair and replace the Greenway pathways.
- We established a long-term tree pruning and planting rotation.
- o In-person Social events returned, led by social chair, Charlie Morgan.
- The Westfield Traffic Calming Project was approved.
- We printed and distributed the 2022 Neighborhood Directory, fully funded by advertisements.

Plans for 2023

- Continue long-term financial planning to fund the long term tree care and pruning rotation and pathway replacement. We are looking for the full tree pruning rotation to take approximately 7 to 10 years. We anticipate it will take some 16 years to accumulate the funds for full pathways replacement.
- Continue the return to in-person social events.
- Distribute periodic newsletters.
- Continue to coordinate Greenway volunteer workdays.
- Look into an "adopt-a-greenway" program.
- Hayden McCann discussed the "Adopt-a-Greenway" program from the perspective of the costs just to maintain the lights in the Greenway, with repairs and repainting and her hope that neighbors would consider financial contributions to get those items done as current budget is tight for that work. Mr. Morgan added for the benefit of new neighbors the fact that the Greenways receive no financial assistance from the City of Madison.
- Lights out on Greenways should be reported to the Greenways email address: greenways@walnutgrovemadison.org.

- Greenways A through D are shown on maps inside the cover of the Directory and on the WGHA website here.
- Ms. Fenster discussed notification for **herbicide applications** on the Greenways via emails to nearby households and via block captains.
- Circle Grants and reimbursement program continues: 3 separate maximum \$500 grants per year rotated among circles; and in addition, \$50 Circle reimbursements for any circle doing beautification on a smaller scale. All requests to be coordinated by the block captain for the circle.
- Pathways Replacement Mr. Morgan, co-chair of the Greenways Committee (for Pathways Repair and Replacement) discussed initial efforts to get a read on the potential costs for replacement of the pathways in the four greenways. A number of contractors have been out to walk the pathways in 2022. It will take some time for the Legacy Fund to build up to the level needed for replacing the pathways in just a single greenway. Based on current 2022 estimates, complete replacement of all four greenway paths will be about \$270,000, and the best estimate is that it will take some 16 years to raise that sum assuming \$15,000 could be placed in the legacy fund each year and not needed for other pathway and greenway needs in the interim. This is an excessively optimistic projection given, for example, that we anticipate repairing at least three sections of the pathways in particular need of repair in 2023 (one area each on Pathways in Greenways A, B and C).
- Danielle Bashirullah chair of the Architectural Control Committee (ACC) reviewed the functioning of the ACC in reviewing certain potential changes to the improvements (including certain outside improvements) to residences in the neighborhood. The ACC is comprised of six homeowners. She explained the use of the ACC Rules and Procedures Appendices to make it simpler for homeowners to zero in on the rules and standards applicable to individual types of improvements or modifications. She reviewed the application and appeal processes under the ACC Rules and Procedures. Finally she reviewed the applications and informal inquiries handled by the ACC in 2022. The ACC acted on eleven (11) applications in 2022. Six were approved, one was approved with conditions imposed, three applications were withdrawn by the homeowners, and one application, for a fence, was denied. Finally, Ms. Bashirullah outlined potential modifications to the Appendices to the ACC Rules and procedures. Once these modifications have been approved by the Board, they will be posted to the Association website under the "Rules" tab.
- Mr. Morgan reviewed the 2023 activities of the Social Committee. We renewed the annual Fourth of July celebration in Walnut Grove Park and had a tailgate potluck in the Park in October which followed a walk through several of the greenways, curated by Hayden McCann and Davey Phillips, to explain the management of the greenways and point out some of the more prominent features and flora. For 2023, Mr. Morgan was considering adding an Easter egg hunt to the calendar, and promoting volunteer opportunities, including Greenway workdays. He encouraged anyone with additional ideas for new social gettogethers to contact him.
- Ms. Fenster reviewed Communications. The new Neighborhood Directory distributed to all homeowners in 2022 made a profit of \$387.00 (ad revenue in excess of printing costs). She encouraged the some fifteen households not yet signed up for digital communications from the Association to contact her to do so in an effort to save administrative effort and mailing expenses.

- Ms. Bashirullah is chair of the Block Captains and reviewed their activities, including such activities as distributing neighborhood directories, new homeowner welcome packets, coordinating block parties, new tree plantings and watering schedules, and circle mowing schedules. There were 17 homes with new owners in 2022 and in January before the annual meeting. Ms. Bashirullah is looking for a new block captain for a section of Walnut Grove Drive on its east side. Block Captains can be identified on the Association website and in the Neighborhood Directory. Ms. Fenster thanked all the Block Captains for all they do for the neighborhood association.
- Treasurer Nick Brown made a presentation for the 2023 proposed budget being recommended by the Board for approval by the members in attendance at the meeting. Among his comments and notations were the following:
 - 90 percent of our fee revenue is spent maintaining or preparing to maintain (in the case of the Legacy Fund) our common areas, including greenways, pathways, pathway lighting, and cul-de-sac circles.
 - We came in under budget for expenses in 2022 due to deferring some temporary pathway repairs, not having the legal expenses for which we budgeted, and saving on social activity expenses.
 - Because of inflationary pressures on utilities (primarily sewer and electricity), mowing and other expenses, the board is recommending an increase in the 2023 annual dues measured by the increase since 2021 in the Consumer Price Index, All Urban Consumers. This specific level of increase is provided for in the Association's Covenants at Part F, paragraph 30, in order to maintain 2021 spending power. The Board recommends raising the dues from \$150 per year to \$170 per year per single family residence, and \$85 per year for condos. This will hopefully allow continued funding of the legacy fund at a desired level notwithstanding the inflationary increases we anticipate on maintenance, tree rotational care and other expected annual expenses.
 - Dues notices are coming out shortly and the Association is looking into new payment options, including Venmo.
 - Mr. Brown is also exploring safe investments, like CD's, for investing the Legacy Fund, given current investment rates of return.
 - One owner asked about the possibility of replacing the pathway light fixtures with solar powered lights, and Ms. Fenster said that in the future that might be considered as a cost savings measure.

Adoption of the 2023 Budget. Amie Mechler-Hickson moved to adopt the 2023 budget being proposed by the board. Rachel Hollender seconded the motion. The motion passed on a vote of 56 to 3, including all proxy votes being voted in favor.

Board of Directors Election. Ms. Fenster solicited nominations from the floor or even individuals to self-nominate to serve a two year term on the Board for 2023-2024. Laurie Howard of Harwood Circle volunteered to run for the board. Danielle Bashirullah, consistent with many years of past practice, made a motion to conduct a single vote on a slate of potential directors consisting of Ms. Fenster, Ms. McCann, Ms. Bashirullah and Ms. Howard. This motion was seconded by Jon Jenson. The motion was approved and the slate of four homeowners elected by a vote of 56 to 1, including all proxy votes being voted in favor. Ms. Fenster invited any owners to sit in on board meetings, which are announced on the Association's website. The Secretary, Mr. Grimmer, can be contacted for the link to attend Zoom meetings.

Open Forum

- Mr. Morgan expressed his appreciation for the excellent leadership that Ms. Fenster had
 provided to the Association over the past several years and particularly during 2023, when a
 number of initiatives were achieved.
- There was a brief discussion about the fact that repainting of the lamp posts along the greenway paths required stripping down to the bare metal, then repriming and repainting, and that Ms. McCann hoped to contract this work out in 2023.
- There was a discussion of whether we were experiencing jumping worms and spongy (gypsy) moths in the neighborhood and on the common areas of the Association. Ms. McCann said she was not aware of these problems yet, and in connection with this concern she renewed her request that nothing should be moved onto the greenways from private property that might pose a potential of moving invasive critters onto the greenways. Ms. Bashirullah and Mr. Griffith recommended that the next newsletter include information on jumping worms and spongy moths and their control.
- Derek Pavelec raised the possibility of needing to move the traditional "third week in May" schedule for the neighborhood garage sale to account for the construction work the City is planning for the Westfield Road traffic calming project. One owner raised the possibility of shifting the sale to summer so that children who are in school in May can be enlisted to help in the families' sales. Mr. Pavelec said we traditionally used the third week in May to "piggyback" off sales occurring then in Wexford and Parkwood Hills. That tends to draw more traffic. But he is open to adjusting the date. He recommends that for planning purposes we set the date by March.

Meeting adjourned at 8:28 pm

The next regular board meeting will be on Monday, February 6, 2023, 6:30 pm (via Zoom) to organize and elect officers for the 2023 WGHA Board. Mr. Grimmer will send out the Zoom link by February 1st.



Bike Trail Update



- Single Track Bike Trail at Walnut Grove Park
 - While Parks is still hoping to install a bike trail at Walnut Grove Park, this
 project has been put on hold.
 - Parks is going to focus their efforts for 2023 on construction at Sycamore Park (east side) and on excess park land along the SW Commuter trail by the Odana Golf Course.
 - Parks may come back to the Walnut Grove neighborhood in 2024 or 2025 with the hope of finding an alignment that will find more acceptance.
 - In the spring of 2023 the Shred to School single track trail, located along the Cannonball Trail by Aldo Leopold School and Park just south of the beltline by Todd Drive, will be open and ready to ride. We encourage neighbors to check it out.

Pheasant Branch Watershed & Sauk Creek Greenway




- The Pheasant Branch Watershed Study is complete. Its goal was to identify causes of flooding and craft potential solutions to try to reduce flooding caused by stormwater.
- Further community engagement on the project will begin in late spring 2023. The City expects the engagement process to last the majority of 2023 and will be more robust than a standard City construction project. Construction isn't likely to begin until 2024.
- Sauk Creek Greenway: The watershed draining through this channel is approximately 1,318 acres. Over time, the channel has degraded. Erosion, fallen trees and sediment forming in the Wexford Pond are key issues.

Traffic Calming Project Update

- The N Westfield Rd traffic calming project construction is set to take place between April and July 2023.
- The intent of this project is enhanced safety for pedestrians accessing the Walnut Grove Park and the surrounding neighborhood
- This project includes
 - three speed humps
 - newly painted crosswalks (continental for visibility with signage)
 - traffic islands installed at N Westfield and Farmington Way
 - reduction of speed limit to 25mph
- Once the project begins, the work should take about three weeks. Traffic will be maintained at all times—speed humps are constructed in halves to maintain traffic.

Our Greenways

WGHA owns 6.7 acres, including just over a mile of paved paths (~5400 feet of paved paths +/- 20 feet) and 36 lamp posts

2022 Greenways Maintenance + Improvement included:

- Mowing, fertilization, and invasives control
- Volunteer work days, including native plantings
- Tree management including removal of dying trees from circles and greenways, Ash tree treatments, pruning of all trees in circles
- New tree plantings to replace select removals

2023 Planning

- Eco Tree Company began a multi-year, rotational tree maintenance program to care for the trees in our greenways and circles, starting with the circles in 2022. This will continue in 2023.
 - Tree removals for hazard and dying trees
 - New tree plantings in Fall '23
- Volunteer Work Days
 - Continuation of work throughout the greenways to remove invasive species.



Our Greenways Continued

- Renewed Policies
 - Invasives Species treatment:
 - Prior to any application of herbicides used to control invasive buckthorn, neighbors in the surrounding area will be notified via email.
 - Circle Grants and Reimbursements:
 - Greenways Committee has taken over major tree removal and tree replanting in Circles. Circle grant applications may still be submitted for other beautification and planting projects and will be approved on a rotating basis, depended on budget allocations.
 - Circle Grants: Maximum amount is \$500, application must be submitted for consideration.
 - Circle Reimbursements: \$50 per year, must be signed off by block captain
 - Lights Out?
 - If you see any greenways lamppost lights out, please contact greenways@walnutgrovemadison.org with the lamppost number and approximate location.

Greenway Paths

- In 2022, we began researching options to repair and replace asphalt paths. Based on preliminary cost estimates and the amounts dedicated for this purpose in the Legacy Fund, it is unlikely that any of the paths will be replaced in the near future.
- Initial quotes gathered for Pathway Replacement:
 - Met with three contractors to gather quotes for replacement
 - Bid Received \$64k for Greenway C (our third longest path)
 - A = 467'
 - B = 1691'
 - C = 1269'
 - D = 1942'
 - Estimated total across all 4 Greenways = \$271k
 - <u>Estimated that it will take ~16 more years</u> to raise the necessary funds IF \$15k is added to the Legacy fund annually

Treasurer Report Highlights: 2022 + 2023 Comments

OPERATING BUDGET

- Total actual 2022 expenses (\$34k) were under budget \$10k due to deferring temporary pathway patching & the timing of Greenway grant spending (\$7k) and underspent legal & social spending (\$3k).
- The 2023 budget recommended by the Board includes adding back the temporary pathway patching while funds continue to grow for long-term replacement.
- The 2023 increased budget additional includes inflationary expenses for water/electricity/ongoing maintenance as well as some outstanding bills that were carried over from 2022 work.

LEGACY FUNDS

 \$30k in funding has been earmarked for pathway replacement, proposed budget allows for an additional \$15k of funding in 2023.


