## ANNUAL MEETING January 29, 2001

- 1. The Annual Meeting began at 7:00 p.m. with Jack Merrill, Chairman of the Architectural Control Committee, welcoming the homeowners present and introducing Alder Sue Hamblin.
- 2. Alder Sue Hamblin began her presentation by informing the meeting that her term will expire on April 17, 2001 and she will not run for reelection. She indicated that Paul Skidmore would probably replace her as he is running unopposed. She then provided the following updates:
  - a. A 7-story office building, "City Center-West," is being built west of the Beltline off Old Sauk Road.
  - b. The Attic Angels have purchased 53 acres adjacent to their existing site on Old Sauk Road for triplexes and single-family elderly housing.
  - c. Madison Public Works Dept. is planning to build a facility near Menards off Mineral Point Road.
  - d. Holy Name Seminary is planning to develop commercial properties along the Beltline and Catholic Charities is also planning to build low-income housing in the same area.
  - e. Snow plowing in December was difficult, but other subdivisions were even worse off than Walnut Grove.

Alder Hamblin answered several questions raised by the homeowners and the Board.

#### **BOARD MEETING**

Minutes: The minutes of the January 24, 2000 Annual Meeting were approved.

The Board recognized Tom Senatori and thanked him for his service to WGHA as a Board member and as its President for the past two years.

# **Committee Report Items:**

#### TREASURER (Kristi Holden)

- Kristi noted that 4 homeowners had yet to pay their 2000 dues.
- In 2000, \$5,000 was taken from reserves to pay for \$3,700 in repairs to light posts in the Greenway due to vandalism.
- For 2001, we will retain the services of Clifton Gunderson again to perform accounting functions for the association.

- In 2001, we will also be looking for a new provider of our insurance liability policy in order to get more competitive premium rates.
- For 2001, we propose to keep the utility and social budget items unchanged.
- For 2001, we propose an increase in the budget for the newsletter because
  Tom Senatori had done the newsletter at no cost.
- For 2001, we will have to pay some of the newsletter costs and the costs for the new Neighborhood Directory out of reserves.

## SOCIAL (Kathy McComb for Debra Wynne)

- Kathy requested volunteers to help with Social Committee activities in the coming year.
- She indicated that we would try to have smaller, but more, events in 2001.

## ARCHITECTURAL CONTROL (Jack Merrill)

 Jack reported that 2000 was relatively quiet with no significant activity or disputes.

## GREENWAYS (Bill Kloster)

- Bill reported that in 2001, we would continue with the same mowing contract that we used last year.
- He also reported that vandals with baseball bats caused over \$3,700 in damage to Greenway light poles in 2000; as a result, no fertilizer was used on the Greenways last year. Fertilizer will be applied in 2001.
- We will seek bids for better insurance liability coverage in 2001.
- In 2001, we would also like to obtain bids to repair cracks in the Greenway pavement to extend the life of the walkways.
- We would also like to sponsor a day or weekend for homeowners, Boy Scouts or Girl Scouts to help clean up the litter in the Greenways. WGHA would provide plastic trash bags and Bill would contact the City for timely pick-up of the trash collected.

## BLOCK CAPTAINS (Kathy McComb)

 Kathy reported that we need 3 more block captains, one each for Foxboro, Stonecrest and Springwood areas.

Homeowner questions to the Board were discussed.
